The 2001 meeting of The Triological Society will be in Palm Desert, California Monday, May 14 through Wednesday, May 16, in conjunction with the Combined Otolaryngological

Spring Meetings (COSM). A superb and varied scientific program will take place in a delightful location. In addition to the regular sessions of The Triological Society, joint sessions will be held with the American Rhinological Society and the American Head and Neck Society. The session with the Rhinological Society will feature a panel discussion on the evolution of surgical indications and management of sinus disease and an invited guest speaker, Aldo Stamm, M.D., from Brazil, who will discuss transnasal endoscopic surgery from minimal to maximal. The joint session with the American Head and Neck Society will feature a panel discussion on early laryngeal cancer.

Bailey, MD will be the invited presidential speaker, and the Ogura Lecturer will be Richard Gacek, MD. Past President Carl N. Patterson, M.D., Dies

CARL NORRIS PATTERSON, 1918–2001

hen Carl Patterson died February 22nd, our specialty lost a dedicated and innovative physician and many of us lost a friend. Carl was the epitome of the academically oriented private practitioner. He was an exceptional teacher, assisting in the training of many residents, both at McPherson Hospital and at the Duke University Medical Center. His example, as a compassionate, well loved physician, and as a perfectionist in his technical skills, influenced young residents and his colleagues. Carl was the universal otolaryngologist, mastering general otolaryngology, facial plastic surgery and later, his true passion, otology.

Carl received his education at Franklin and Marshall College and the University of Maryland School of Medicine and completed his residency at Mercy Hospital in Baltimore. He served as a surgeon in the Navy during World War II. He was a member of most of our society's specialty organizations as well as the American Medical Association and the American College of Surgeons. Not being content to be only a member, Carl's leadership abilities were evident, locally and nationally. He was president of the North Carolina Society of Otolaryngology and founded the Training Center for Hearing Impaired Children in Durham. Nationally, he served as vice president of the American Academy of Otolaryngology-Head and Neck Surgery, as one of the early presidents of the American Society of Facial Plastic and Reconstructive Surgery, and, in 1984, became President of the American Laryngological, Rhinological and Otological Society.

Carl loved the Triological Society, participating fully in its social and scientific programs. In his presidential address he said, "Let each of you use the Triological Society as your touchstone, finding in it the amalgamation of the glorious record of its past, the dynamic present, and the portent for a vigorous growth for the future."

On a personal note, Carl was a friend and colleague for forty years. He served as an Associate Clinical Professor of Otolaryngology at the Duke University Medical Center. His friendship, support and advice, over the years, have been of inestimable value to me and to the department. As a measure of his thoughtfulness, I remember moving into a new home some years ago. Carl and Ruth came over before we unpacked, bringing a bottle of champagne and glasses. We sat on packing cases, toasting our friendship and our new home.

Carl is survived by his lovely wife of 57 years, Ruth, whose love for the Triological equaled his, by a daughter, Patricia Patterson LeClerc of Canton, N.Y., two sons, Lee Austin Patterson of Durham, N.C., Carl Norris Patterson, Jr. of Raleigh, N.C., and three grandchildren.

Finally, I again quote from his presidential address. In referring to the remarkable advances in medicine, he stated, "We need in our specialty inquisitive physicians who have the simplicity to wonder, the ability to question, the power to generalize, and the capacity to apply." Carl had all of the attributes.

We will miss him.
